District Projects

Hello all, I hope everyone had a great summer and looking forward to Fall. I wanted to update everyone on the projects we have accomplished this year and what we are planning for next year.

This year accomplishments:

- Repaired a slight dip in the sewer line on Allendale Dr. The sewer line had settled over the
 years, therefore it needed to be raised, releveled, and reenforced the foundation to
 prevent this from reoccurring. This project come in under budget and on scheduled.
- Repaired the sprinkler systems in South Manchester Park. The system was in disrepair and had to replace the entire system. Instead of paying 15K for a contractor the work was completed by our team cutting the cost in half.
- The lift station located near the open space and Stapleton was upgraded with an emergency bypass (Pictured enclosed). The cost to this project also came in underbudget but we did have some delay caused by Covid-19. The emergency bypass is designed to allow the district to handle any emergency situations instead of outsourcing.
- Finally, for this year, Pump house 3, located off of Londonderry, is being upgraded and both wells 3 & 4 were rehabilitated. This is still in progress and should be completed by the end of the year.

Scheduled for next year;

- Rehabilitation of Well 7, a new water booster station and the installation of pressure regulating valves (PRVs).
- Due to ongoing construction of filing 14 to ensure that water pressure is maintained throughout the community. The new booster station with stronger pumps will increase overall pressure to 85-100 PSI and the PRVs will ensure we deliver a constant pressure of 65 PSI to all homes.

Covered Shut off Valves

Passing through our District, you can see a lot of different types of beautifully landscaped yards. From a multitiered rock xeriscape to lush new green grass, they make our neighborhoods look great. However, a problem we are finding especially in the newer parts of our District, is that the landscape contractors are covering over the shutoff valves known as curb stops. Also, the pits where the meters reside are being buried using boulders, mulch, and grass. This poses a problem for multiple reasons:

- 1) We can't get to the meter when they need to be maintained or serviced.
- 2) The radio network has a harder time receiving the appropriate signal for billing and alerts.
- 3) In the event of an emergency your valves are not accessible.
- 4) It is against District Rules and Regulations.

We here at the District ask homeowners to be mindful when contractors are putting in new landscaping and that they please do not bury our utilities. As always, locates should be called in to 811 beforehand so a technician can come out and mark where those appurtenances are. Thanks, and keep up the good work!

Frozen Pumpkin Mousse Pie

Crust

1 ½ cups Graham cracker crumbs ¼ packed brown sugar 6 tablespoons butter, melted

Filling

1 can (15 ounces) solid-pack pumpkin
1 jar (7 ounces) marshmallow crème
14 cup packed brown sugar
2 teaspoons pumpkin pie spice
1 carton (12 ounces) frozen whipped topping, thawed, divided

Instructions

- 1. In a bowl, combine the cracker crumbs, brown sugar, and butter. Press onto the bottom and up the sides of a greased 9-in. deep-dish pie plate. Bake at 350° for 7-9 minutes or until lightly browned. Cool completely on a wire rack.
- For filling, in a large bowl, whisk the pumpkin, marshmallow creme, brown sugar and pumpkin pie spice. Fold in 3-1/2 cups whipped topping. Spoon into prepared crust. Cover and freeze for at least 4 hours or until firm. Garnish with remaining whipped topping.
